And WHEREAS it is desirable for the Government of the Republic of Singapore to ratify the Agreement.

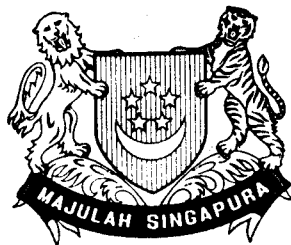
Now, THEREFORE, the Government of the Republic of Singapore, having considered the Agreement, do hereby ratify the Agreement.

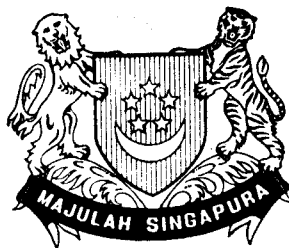


