### INSTRUMENT OF RATIFICATION

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, THAT WHEREAS, the Protocol on Dispute Settlement Mechanism was signed in behalf of the Republic of the Philippines, by Secretary Cesar B. Bautista, in Manila on 20 November 1996;

WHEREAS, this Protocol is an expansion of Article 9 of the Framework Agreement on Enhancing ASEAN Economic Cooperation that has entered into force upon signing by the ASEAN Heads of Government in Singapore on 28 January 1992;

WHEREAS, this Protocol applies to the disputes brought pursuant to the consultation and settlement provisions of the said Framework Agreement, the forty-seven agreements on ASEAN Economic Cooperation listed and incorporated as Appendix I of the Protocol and future ASEAN economic agreements;

WHEREAS, this Protocol provides the procedure for consultations, good offices, conciliation or mediation as options of the parties to the dispute before elevating the controversy to the Senior Economic Officials Meeting (SEOM);

WHEREAS, this Protocol provides that the SEOM may opt to resolve the dispute on its own motion, or to create a panel, or refer the controversy to a special body that would assist it in deciding the dispute;

WHEREAS, this Protocol provides the procedure for appealing the decision of the SEOM to the ASEAN Economic Ministers (AEM), as well as the modes of securing compliance with the final decision by compensation or suspension of concessions;

WHEREAS, this Protocol shall enter into force upon the deposit of the instruments of ratification or acceptance by all signatory governments with the Secretary-General of ASEAN;

NOW THEREFORE, be it known that I, Fidel V. Ramos, President of the Republic of the Philippines, after having read and considered the aforesaid Protocol on Dispute Settlement Mechanism do hereby ratify and confirm the same and every article and clause thereof;



IN TESTIMONY WHEREOF, I have hereunto set my hand and cause the seal of the Republic of the Philippines to be affixed.
