It is therefore to be expected that during two years, the need for a strong central secretariat has been widely recognized in keeping with the intensity of ASEAN cooperative

ventures. ASEAN can look forward with great optimism. Its solidarity can never be in doubt. And as a regional organization it has proved its viability and durability.

In handing over my duty to the new Secretary General, I am confident that the ASEAN Secretariat will grow in stature and importance.
