IMPLEMENTATION AGREEMENT

Basis of the Agreement

The following shall form the basis of this Agreement:

Exchange of Notes between the Government of the Federal Republic of Germany and the ASEAN Secretariat on Technical Cooperation concluded on 9 November 2007 (see Annex 1)

In accordance with paragraph 5 of the aforementioned Arrangement / Exchange of Notes, dated 2 October 2007, and as confirmed by the ASEAN Secretariat on 9 November 2007, details of the Project are to be laid down in an implementation agreement between GTZ and ASEAN. GTZ is acting in execution of the commission with which it has been charged by the Government of the Federal Republic of Germany.





1. Project objective and indicators

The objective of this Project is:

The ASEAN Member States and the ASEAN Secretariat improve their intergovernmental cooperation in forestry, in line with the Plan of Operations Phase II (August 2006 – July 2010) as approved by the 9th Meeting of the ASEAN Senior Officials on Forestry (ASOF) on 18 August 2006 (See Annex 2).

The indicators are:

- The outcomes arising from the regional forest policy dialogue, particularly in terms of sustainable forest management (SFM), are the object of national consultations and implementation in all ASEAN Member States (benchmarks: 7 International Criteria of SFM, ASEAN criteria for sustainable management of tropical forests and VAP Chapter 5.1 Resource Mobilization);
- The regional communication and consultation processes lead to qualitative improvements of the Strategic Plan of Action (SPA) in Forestry (benchmarks: VAP Programme Area ref. no. 3.3.11, OECD principles and CHM-tools); and
- The ASEAN Member States report on the implementation of the SPA-Forestry in compliance with the requirements of economic integration and environmental sustainability (benchmarks: VAP Pillars' II and III scorecards, ASEAN Economic Community (AEC) and ASEAN Socio-cultural Community (ASCC) Blueprints Scorecards and VAP Programme Area ref. no. 4.1.2).

GTZ and ASEAN are jointly committed to this objective. The aforementioned Plan of Operations may be amended from time to time depending on the requirements of ASOF and ASEAN Secretariat.

2. Contributions to the Project by the Government of the Federal Republic of Germany through GTZ

In accordance with the aforementioned Arrangement / Exchange of Notes, concluded on 9 November 2007, the Government of the Federal Republic of Germany shall provide GTZ with up to EUR 3.100.000 (in words three million one hundred thousand Euros) as German contribution. This amount shall include the costs incurred by the German Implementing Organisation.

2.1. Provision of experts

For the purposes of this Agreement, GTZ shall make the followings available for the project:

- a seconded expert (Principal Advisor) on international forest policy to be responsible for the management of the German contribution who shall, at the same time, be the team leader of experts made available for this Project for the duration of the phase described in Article 4 below;
- a seconded expert (Technical Advisor) on forest policy and communication to be responsible for information and knowledge management as well as monitoring & evaluation for up to 48 person-months;

 a national expert (Programme Officer) on current forestry issues and regional knowledge management for up to 22 person-months.

The period of secondment of the aforementioned experts shall also include annual leave in accordance with the provisions of German laws.

- international and regional short-term experts for the following fields:
 - -- activities related to implementing forestry-related AEC and ASCC Blueprints and Scorecards;
 - -- implementation of the international forest regime (e.g. ASEAN criteria & indicators for sustainable management of tropical forests);
 - -- forest and timber certification;
 - -- forestry-related trade issues;
 - -- Peer Consultation Framework (PCF) initiatives in forestry; and
 - -- emerging forestry policy issues.

2.2. Supply of materials and equipment

GTZ shall supply the following items to equip the technical infrastructure:

- 1 vehicle (replacement of existing vehicle, in case of need)
- computers and accessories
- media (posters, leaflets, publications)

2.3. Capacity Development Activities

GTZ shall support information and knowledge management in the region and provide technical, managerial and other requested capacity development to the ASEAN Member States and the ASEAN Secretariat.

2.4. Operational and administrative costs

GTZ shall bear the operational and/or administrative costs associated with the management of the German contribution to the Project. This includes the provision of project administrative and support staff.

3. Contributions by ASEAN Secretariat

3.1. Provision of experts and associated personnel

For the purposes of this Agreement, the ASEAN Secretariat shall assign the following counterpart officers as to collaborate and ensure the implementation of project activities for the duration of the phase described in Article 4.3 below:

- one (1) Senior Officer; and
- one (1) Technical Officer.

Associated personnel shall be made available as and when deemed necessary and appropriate.

3.2. Provision of sites, buildings and work premises

The ASEAN Secretariat shall make available to the Project, free of charge, premises, office space including equipment and furnishings required for Project implementation, insofar as such equipment and furnishings are not supplied by GTZ.





4. Other provisions

4.1. Evaluation

- GTZ may undertake an evaluation of the Project during or after implementation of this Agreement. To this end, GTZ shall second experts/appraisers to the Project.
- ASEAN Secretariat shall participate in the evaluation and shall assist the expert(s)/ appraiser(s) in their work and allow them to examine all projectrelated documents.
- ASEAN Secretariat shall be informed of the results of the evaluation by means of a report.

4.2. Suspension of contributions

GTZ may suspend its contributions if:

- (a) ASEAN Secretariat fails to fulfil obligations under this Agreement or out of arrangements in respect of this Agreement; and
- (b) Circumstances arise which preclude, or place in considerable jeopardy, the objective of the Project described in Article 1.

4.3. Term of Agreement

Notwithstanding Article 4.2 (Suspension of contributions), this Agreement shall be valid for the duration of the ongoing phase of the Project (currently scheduled to run from 1st August 2006 to 31st July 2010). The term of this Agreement may be extended in the event of a delay in the execution of the German contribution as laid down in this Agreement and in the execution of the agreed contributions by ASEAN Secretariat.

4.4. Adjustment of Agreement

In the event that provisions of this Agreement do not further the efficient achievement of the objective defined in Article 1, GTZ and ASEAN Secretariat may adjust these provisions by mutual consent at any stage during the implementation of the Project. Any adjustments shall be made in writing.

4.5. Termination of Agreement

If one of the circumstances described in Suspention of contributions in Article 4.2 arises and is still in existence after a time-limit to be agreed upon by GTZ with ASEAN Secretariat, or if it is not eliminated within this period, GTZ may, with the consent of the Government of the Federal Republic of Germany, prematurely terminate the implementation of this Agreement.

4.6. Written form

Amendments and additions to this Agreement, and any other important declarations and communications of significance to the execution of this Agreement, shall be made in writing. In the case of declarations and communications to GTZ, it shall suffice for them to be received by the team leader referred to in Article 2.





4.7. Agreements with individual implementing organisations

The person responsible for the contribution by GTZ and the person(s) responsible for the contributions by the partner organisation or other implementing organisations may together conclude a binding agreement on additional details concerning execution of the Project (e.g. on the basis of a plan of operations), or in any other suitable way lay down those details in writing and, where necessary, adjust any such agreement to take into account developments in the Project.

4.8. Government arrangements

As to the rest, the Exchange of Notes between the Government of the Federal Republic of Germany and the ASEAN Secretariat on Technical Cooperation concluded on 9 November 2007 (see Annex 1), both referred to at the beginning of this Agreement, shall also apply to this Agreement.

4.9. Entry into force, copies

This Agreement shall enter into force on signing date by both parties hereto. It shall be drawn up in three originals.



I have the honour to refer to Note Verbale number 1057/01 from the Embassy of the Federal Republic of Germany in Jakarta dated 20 December 2001, confirmed by Note Verbale number 36/02 from the Secretariat of the Association of Southeast Asian Nations, hereinafter referred to as ASEAN, and to Note Verbale number 154/03 from the Embassy of the Federal Republic of Germany in Jakarta dated 3 March 2003 confirmed by Note Verbale number 137/03 from the ASEAN Secretariat dated 25 March 2003 and to propose on behalf of the Government of the Federal Republic of Germany that the following Arrangement concerning the continuation of the project Regional Forest Programme for Southeast Asia, Phase II be concluded.

- 1. The Government of the Federal Republic of Germany and the ASEAN Secretariat shall jointly promote the project Regional Forest Programme for Southeast Asia,

 Phase II.
- 2. The aim of the project is for the ASEAN Secretariat and the relevant institutions in the ASEAN member states to improve their international cooperation in the forest sphere.
- 3. The Government of the Federal Republic of Germany shall make available for the project contributions totalling up to EUR 3,100,000 (three million one hundred thousand euro) in the form of personnel, inputs and, where appropriate, financial contributions. It shall charge the Deutsche Gesellschaft für Technische

Zusammenarbeit GmbH (GTZ), Eschborn, with implementation.

- 4. The ASEAN Secretariat shall be the project-executing agency. It shall guarantee that the project is provided with an itemized budget of its own in order to ensure its smooth implementation and shall ensure that the institutions charged by it with implementation provide the necessary contributions for the project.
- 5. Details of the project and of the contributions and obligations shall be laid down in an implementation agreement and, where appropriate, a financing agreement, to be concluded between the GTZ and the ASEAN Secretariat, which shall be subject to the laws and regulations applicable in the Federal Republic of Germany.
- 6. If the project is not implemented at all, or only in part, it may be replaced by another project provided the Government of the Federal Republic of Germany and the ASEAN Secretariat so agree.
- 7. The commitment of the Government of the Federal Republic of Germany for the project shall lapse without replacement if the implementation and financing agreements referred to in paragraph 5 above are not concluded within a period of 8 years after the year in which the commitment was made. For the commitments made for this project, without prejudice to the provisions of paragraph 6 above, this deadline shall be 31 December 2009.
- 8. The ASEAN Secretariat will, in consultation with ASEAN Member Countries,

Germany for purpose of the Programme be exempted from taxes, duties and other charges; and

the ASEAN Secretariat will grant to the German seconded experts of the Programme- and their families benefits, privileges and exemption which are not less favourable than those granted to expatriates under other bilateral and multilateral agreements or arrangements for technical cooperation.

9. This Arrangement shall be concluded in the German and English languages, both texts being equally authentic.

If the ASEAN Secretariat agrees to the proposals contained in paragraphs 1 to 9 above, this Note and your Note in reply thereto expressing the agreement of the ASEAN Secretariat shall constitute an Arrangement between the Government of the Federal Republic of Germany and the ASEAN Secretariat, which shall enter into force on the date of your Note in reply.
