## INSTRUMENT OF ACCEPTANCE

of ASEAN Multilateral Agreement on the Full Liberalisation of Air Freight Services

WHEREAS, the ASEAN Multilateral Agreement on the Full Liberalisation of Air Freight Services was signed at Manila, Philippines, on 20th May 2009!

WHEREAS its Article 20 Paragraph 2 stipulates that this Agreement is subject to ratification or acceptance by the Contracting Parties. The Instruments of Ratification or Acceptance shall be deposited with the Depository who shall promptly inform each Contracting Party of such deposit;
