INSTRUMENT OF NOTIFICATION

WHEREAS, the Government of Malaysia has signed the Agreement on Cultural Cooperation Between the Governments of the Member States of the Association of Southeast Asian Nations (ASEAN) and the Government of the Russian Federation (the Agreement) on the Thirtieth Day of October in the Year Two Thousand and Ten in Ha Noi, Vietnam;

AND WHEREAS, Article 22 of the Agreement provides that the Agreement shall enter into force on the day of the receipt by the Secretary-General of ASEAN of written notification that the Governments of all Member States of ASEAN and the Government of the Russian Federation have completed their internal procedures necessary for its entry into force;

NOW THEREFORE, the Government of Malaysia hereby notifies the Secretary-General of ASEAN of the completion of its internal procedures for entry into force of the Agreement;

IN WITNESS THEREOF, this Instrument of Notification is signed and sealed by the Minister of Foreign Affairs, of Malaysia.
