INSTRUMENT OF NOTIFICATION

WHEREAS, the Air Transport Agreement between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China (hereinafter referred to as "the Agreement") was signed in Bandar Seri Begawan, Brunei Darussalam, on the Twelfth Day of November, in the Year Two Thousand and Ten;
