INSTRUMENT OF RATIFICATION

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the Protocol 3 to the ASEAN Framework Agreement on the Facilitation of Goods in Transit (Types and Quantity of Road Vehicles) was signed in Hanoi, Vietnam on 15 September 1999;

WHEREAS, pursuant to the ASEAN Framework Agreement on the Facilitation of Goods in Transit, the Protocol applies to all road transit transport vehicles and transport operators as defined in Article 1 thereof;

WHEREAS, under the Protocol, each Contracting Party will be allowed to use not more than sixty (60) road transit transport vehicles and the transit transport operators will not be permitted to engage in transit transport using road vehicles other than those specified as road transit transport vehicles in Annex 1;

WHEREAS, the Contracting Parties agree to authorize the unhindered access and movement of road transit transport vehicles on designated transit transport routes, provided that the vehicle complies with the road traffic rules and regulations of the Contracting Party across whose territory it passes;

WHEREAS, the road transport transit vehicle to which the Protocol applies will not be allowed to engage in transit transport unless it complies with the Mandatory Technical Requirements as specified in Protocol 4;

WHEREAS, Article 8 of the Protocol provides that it shall enter into force upon the deposit of Instruments of Ratification or Acceptance by all Contracting Parties with the ASEAN Secretary-General;

WHEREAS, this Protocol is not one of those treaties and international agreements contemplated in Section 21, Article VII of the 1987 Constitution which require the concurrence of the Senate, but an executive agreement which can be validly entered into by the President in the exercise of his treaty making powers;

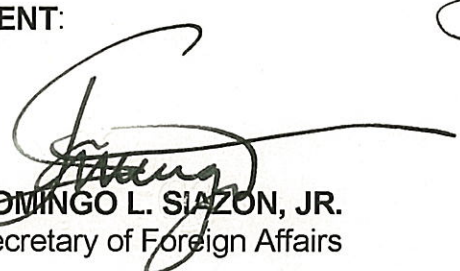
NOW, THEREFORE, be it known that **I, JOSEPH EJERCITO ESTRADA**, President of the Republic of the Philippines, after having seen and considered the aforementioned Protocol 3 to the ASEAN Framework Agreement on the Facilitation of Goods in Transit (Types and Quantity of Road Vehicles), do hereby ratify and confirm the same and every Article and Clause thereof.
