

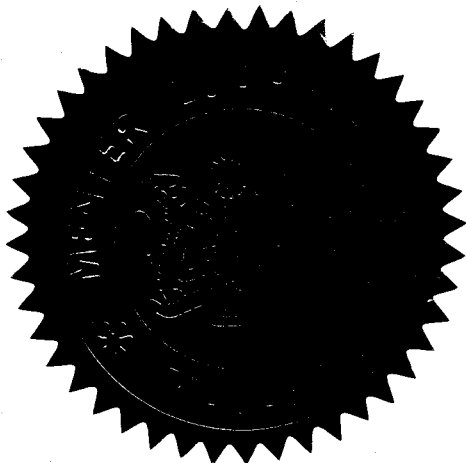
## **INSTRUMENT OF RATIFICATION**



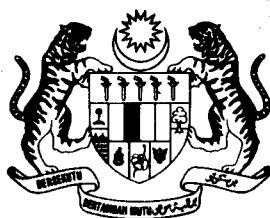
