



INSTRUMENT OF RATIFICATION

ASEAN FRAMEWORK AGREEMENT ON THE FACILITATION OF GOODS IN TRANSIT PROTOCOL 5: ASEAN SCHEME OF COMPULSORY MOTOR VEHICLE INSURANCE

WHEREAS Protocol 5 of the ASEAN Framework Agreement on the Facilitation of Goods In Transit: ASEAN Scheme of Compulsory Motor Vehicle Insurance was signed in Kuala Lumpur on 4 April 2001 by the duly authorized Representatives of the Governments of Brunei Darussalam, the Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand and the Socialist Republic of Viet Nam;

WHEREAS paragraph 4 of Article 15 provides that the Protocol shall enter into force upon the deposit of Instruments of Ratification or Acceptance by all Contracting Parties with the Secretary-General of ASEAN;

NOW THEREFORE, the Government of Brunei Darussalam having considered the said Protocol, hereby formally ratifies the same and undertakes faithfully to perform and carry out the stipulations contained therein.
