

INSTRUMENT OF RATIFICATION

to whom these presents shall come, greetings:

KNOW YE, that the Agreement on Maritime Transport between the Governments of the Member Countries of the Association of Southeast Asian Nations and Government of the People's Republic of China was signed on 02 November 2007 in Singapore:

WHEREAS, the Agreement aims to provide facilitations and cooperation in improving the conditions under which maritime cargo and passenger transport operations are carried out between the ports of the Contracting Partles, as well as between the ports of the Contracting Parties and the ports of third countries, for the benefit of economic operators of the Contracting Parties;

WHEREAS, the Agreement provides that it applies to the international maritime cargo and passenger transport between the ports of the Member Countries of ASEAN and China; it shall not apply to domestic maritime transport purely between the ports within any Member Country of ASEAN or between the ports of China; it shall not affect the application of the bilateral agreements concluded between the Member Countries of ASEAN and China for Issues falling outside its scope and shall not affect the right of vessels of third parties to engage in cargo and passenger transport between the ports of either Contracting Party and a third party:

NOW, THEREFORE, be it known that I, GLORIA MACAPAGAL ARROYO, President of the Republic of the Philippines, after having seen and considered the aforementioned Agreement on Maritime Transport between the Governments of the Member Countries of the Association of Southeast Asian Nations and the Government of the People's Republic of China, do hereby ratify and confirm the same and each and every Article and Clause thereof.

IN TESTIMONY WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
