INSTRUMENT OF RATIFICATION

TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the *Agreement on Trade in Services Under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member States of the Association of Southeast Asian Nations and the Republic of Korea*, and the *Letter of Understanding Among the Parties to the Agreement on Trade in Services Under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member States of the Association of Southeast Asian Nations and the Republic of Korea* were both signed on 21 November 2007 in Singapore;

WHEREAS, the *Agreement on Trade in Services*, consisting of thirty-two (32) articles, aims to enhance economic cooperation and deepen economic integration among the Parties by progressively liberalizing trade in services in the four modes of supply, namely: cross-border supply, consumption abroad, commercial presence and movement of natural persons.;

WHEREAS, the *Letter of Understanding* shall form an integral part of the Agreement and shall take effect on the same date as the Agreement on Trade in Services;

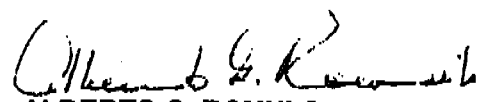
WHEREAS, Article 31 of the *Agreement on Trade in Services* provides that it shall enter into force on the first day of the second month following the latter date on which at least one ASEAN Member Country and Korea have notified all the other Parties in writing of the completion of their internal procedures;

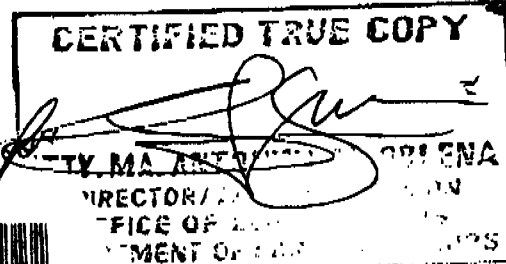
