OF THE AGREEMENT ON TRADE IN SERVICES UNDER THE FRAMEWORK
AGREEMENT ON COMPREHENSIVE ECONOMIC COOPERATION AMONG
THE GOVERNMENTS OF THE MEMBER COUNTRIES OF THE ASSOCIATION
OF SOUTHEAST ASIAN NATIONS AND THE REPUBLIC OF KOREA**

WHEREAS, the Royal Government of Cambodia has signed the Agreement on Trade in Services Under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea, on 21st November 2007, Singapore;

WHEREAS, the article 31.2 of this Agreement provides that a Party Shall, upon the completion of its internal procedures for the entry into force of this Agreement, notify all the other Parties in writing;

WHEREAS, His Majesty the King of Cambodia ratified the above-mentioned Agreement on 22 October 2009;

NOW THEREFORE, the Royal Government of Cambodia, having considered the above-mentioned Agreement, undertakes faithfully to carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
