I am pleased to inform you that Brunei Darussalam has completed the internal procedures for the entry into force of Multilateral Agreement on Air Services (MAAS) and Multilateral Agreements on Air Freight Services (MAAFS) together with its respective Protocols as below;

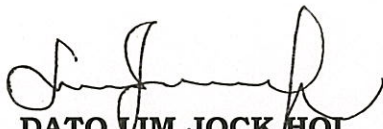
1. ASEAN Multilateral Agreement on the Full Liberalisation of Air Freight Services;
 - i. Protocol 1 – on Unlimited Third, Fourth and Fifth Freedom Traffic Rights among Designated Points in ASEAN;
 - ii. Protocol 2 – on Unlimited Third, Fourth and Fifth Freedom Traffic Rights among All Points with International Airports in ASEAN;
2. ASEAN Multilateral Agreement on Air Services;
 - i. Protocol 1 – On Unlimited Third and Fourth Freedom Traffic Rights within the ASEAN Sub-Region;
 - ii. Protocol 2 – On Unlimited Fifth Freedom Traffic Rights within the ASEAN Sub-Region;
 - iii. Protocol 3 – on Unlimited Third and Fourth Freedom Traffic Rights between the ASEAN Sub-Regions;
 - iv. Protocol 4 – on Unlimited Fifth Freedom Traffic Rights between the ASEAN Sub-Regions;
 - v. Protocol 5 – on Unlimited Third and Fourth Freedom Traffic Rights between ASEAN Capital Cities;
 - vi. Protocol 6 – On Unlimited Fifth Freedom Traffic Rights between ASEAN Capital Cities.
