INSTRUMENT OF RATIFICATION

WHEREAS the ASEAN Plus Three Emergency Rice Reserve Agreement was signed at Jakarta, Indonesia, on 7 October 2011, by the duly authorised Representatives of the Governments of Brunei Darussalam, the Kingdom of Cambodia, the Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Republic of the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand, the Socialist Republic of Viet Nam, the People's Republic of China, Japan and the Republic of Korea;

WHEREAS Article 10, paragraphs 1 and 2 of the Agreement stipulates that this Agreement shall be open for signature and subject to ratification, acceptance or approval by the ASEAN Plus Three Countries, and the instruments of ratification, acceptance or approval shall be deposited with the Depository (Secretary-General of ASEAN); and

WHEREAS Article 10, paragraph 3 of the Agreement stipulates that this Agreement shall enter into force on the thirtieth day after the date on which at least six ASEAN Member States and one Plus Three Country have deposited their instruments of ratification, acceptance or approval, and Article 10, paragraph 4 stipulates that for each ASEAN Plus Three Country that ratifies, accepts or approves this Agreement after the conditions set out in Paragraph 3 for the entry into force have been fulfilled, this Agreement shall enter into force on the thirtieth day following the date of deposit of its instrument of ratification, acceptance or approval;

THE GOVERNMENT OF THE KINGDOM OF THAILAND, having considered the aforesaid Agreement, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

DONE at the Ministry of Foreign Affairs, Bangkok, this 21st Day of December in the Year Two thousand Five hundred and Fifty-four of the Buddhist Era, corresponding to the Year Two thousand and Eleven of the Christian Era.
