

INSTRUMENT OF RATIFICATION

WHEREAS, the Government of the Republic of Indonesia has signed Memorandum of Understanding on Establishing the ASEAN-China Centre between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China, on 25 October 2009 in Cha-Am Hua Hin, Thailand;

AND WHEREAS, the Government of the Republic of Indonesia, in accordance with Article 25 of the Memorandum of Understanding, having examined and considered the aforesaid Memorandum of Understanding, has decided to ratify the same through Presidential Decree No. 75 year 2011 concerning Ratification of Memorandum of Understanding on Establishing the ASEAN-China Centre between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China;

NOW THEREFORE, BE IT KNOWN, the Government of the Republic of Indonesia hereby confirms and ratifies the said Memorandum of Understanding and undertakes to perform and carry out all the stipulations therein contained;

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister for Foreign Affairs of the Republic of Indonesia.
