INSTRUMENT OF RATIFICATION

TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the *Memorandum of Understanding on Establishing the ASEAN-Korea Centre Between the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea* was signed on 21 November 2007 in Singapore;

WHEREAS, the *Memorandum of Understanding* provides for the establishment of an institution known as the ASEAN-Korea Centre in order to increase trade volume, accelerate investment flow, invigorate tourism and enrich cultural heritage between the ASEAN Member Countries and the Republic of Korea (ROK). The headquarters of the Centre shall be located in Seoul;

WHEREAS, Article 26 of the *Memorandum of Understanding* further provides that it shall enter into force 30 days after the date of the last deposit of the instruments of ratification or acceptance by all ASEAN Member Countries and the ROK;

NOW, THEREFORE, be it known that I, **GLORIA MACAPAGAL ARROYO**, President of the Republic of the Philippines, after having seen and considered the aforementioned *Memorandum of Understanding on Establishing the ASEAN-Korea Centre Between the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea*, do hereby ratify and confirm the same and each and every Article and Clause thereof.

IN TESTIMONY WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
