

Instrument of Ratification

WHEREAS the Protocol to Implement the Third Package of Commitments under the ASEAN Framework Agreement on Services was done on 31 December 2001; and

WHEREAS Paragraph 5 of the Protocol stipulates that this Protocol shall enter into force upon the deposit of instruments of ratification or acceptance by all signatory governments with the Secretary-General of ASEAN, which shall be done not later than 31 March 2002;


