**INSTRUMENT OF RATIFICATION
OF THE AGREEMENT ON INVESTMENT OF THE FRAMEWORK
AGREEMENT ON COMPREHENSIVE ECONOMIC COOPERATION
BETWEEN THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS
AND THE PEOPLE'S REPUBLIC OF CHINA**

WHEREAS, the Royal Government of Cambodia has signed the Agreement on Investment of the Framework Agreement on Comprehensive Economic Cooperation Between the Association of Southeast Asian Nations and the People's Republic of China, on 15 August 2009, at Bangkok, Thailand;

WHEREAS, the article 27.4 of the Agreement provides that a Party shall upon the completion of its internal procedures for the entry into force of this Agreement notify the other Parties in writing;

WHEREAS, His Majesty the King of Cambodia ratified the above-mentioned Agreement on 02 August 2010;

NOW THEREFORE, the Royal Government of Cambodia, having considered the above-mentioned Agreement, undertakes faithfully to carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
