# THE GOVERNMENT OF THE REPUBLIC OF THE UNION OF MYANMAR MINISTRY OF HOME AFFAIRS

## INSTRUMENT OF RATIFICATION

WHEREAS, the ASEAN Convention on Counter Terrorism was done at Cebu, Philippines at the Twelveth ASEAN Summit on the Thirteenth day of January in the year Two Thousand and Seven.

AND WHEREAS, the Government of the Republic of the Union of Myanmar in accordance with Article XX of the said Convention has decided to ratify the Convention.

DECLARE, that the Republic of the Union of Myanmar is not a Party to the following Treaties listed in the Article II of the Convention that these Treaties shall be deemed not to be included in paragraph 1 of the Article II of the Convention in the application of this Convention to the Republic of the Union of Myanmar.

- 1(e) Convention on the Physical Protection of Nuclear Material, adopted in Vienna on 26 October 1979;
- 1(f) Protocol for the Suppression of Unlawful Acts of Violence at Airports Serving International Civil Aviation, Supplementary to the Convention for the Suppression of Unlawful Acts Against the Safety of Civil Aviation, done at Montreal on 24 February 1988;
- 1(k) International Convention for the Suppression of Acts of Nuclear Terrorism, adopted in New York on 13 April 2005;
- 1(1) Amendment to the Convention on the Physical Protection of Nuclear Material, done at Vienna 8 July 2005;
- 1(m) Protocol of 2005 to the Convention for the Suppression of Unlawful Acts Against the Safety of Maritime Navigation, done at London on 14 October 2005; and
- 1(n) Protocol of 2005 to the Protocol for the Suppression of Unlawful Acts Against the Safety of Fixed Platforms Located on the Continental Shelf, done at London on 14 October 2005;

NOW THEREFORE, the Government of the Republic of the Union of Myanmar having considered the said Convention, hereby confirms and ratifies the same and undertakes to perform and carry out the stipulations therein contained.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Union Minister for Home Affairs, the Republic of the Union of Myanmar.
