

INSTRUMENT OF NOTIFICATION

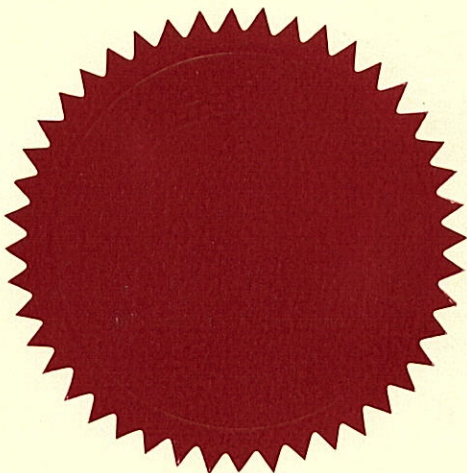
WHEREAS the ASEAN Trade in Goods Agreement of the Association of Southeast Asian Nations (hereinafter referred to as "the Agreement") was signed on behalf of the Government of Malaysia on 26 February 2009 in Hua Hin, Thailand;

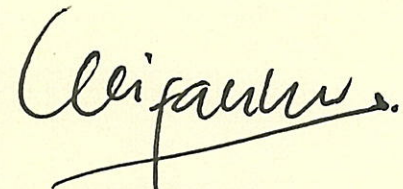
AND WHEREAS Article 96 (2) of the Agreement provides that Agreement shall enter into force, after all Member States have notified or, where necessary, deposited instruments of ratifications with the Secretary-General of ASEAN upon completion of their internal procedures, which shall not take more than one hundred and eighty (180) days after the signing of this Agreement;

NOW THEREFORE, the Government of Malaysia, having considered the Agreement, hereby notifies the other Parties of Malaysia's completion of legal procedures necessary for the entry into force of this Agreement.

IN WITNESS THEREOF, this Instrument of Notification is signed and sealed by the Minister of Foreign Affairs, Malaysia.
