## TO WHOM THESE PRESENTS SHALL COME, GREETINGS:


**KNOW YE**, that whereas, the *Agreement on Trade in Goods of the Agreement on Comprehensive Economic Co-operation between the Association of Southeast Asian Nations and the People's Republic of China*, was signed on 29 November 2004 in Vientiane, Lao PDR;

**WHEREAS**, the *Agreement* is one of the components of the Framework Agreement on Comprehensive Economic Cooperation between ASEAN and China (Framework Agreement) and the Protocol to Amend the Framework Agreement, which reflect the Parties' commitment to establish the ASEAN-China Free Trade Area covering trade in goods by 2010 for ASEAN 6 and China and by 2015 for the newer ASEAN Member States;


**NOW, THEREFORE**, be it known that I, **GLORIA MACAPAGAL ARROYO**, President of the Republic of the Philippines, after having seen and considered the aforementioned *Agreement on Trade in Goods of the Agreement on Comprehensive Economic Co-operation between the Association of Southeast Asian Nations and the People's Republic of China*, do hereby ratify and confirm the same and each and every Article and Clause thereof.

**IN TESTIMONY WHEREOF**, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

Dear Excellency:


