## INSTRUMENT OF RATIFICATION

**TO ALL TO WHOM THESE PRESENTS SHALL COME,  
GREETINGS:**

**KNOW YE**, that whereas, the *Framework Agreement on Comprehensive Economic Cooperation between ASEAN and India*, was signed in Bali on 8 October 2003;

**WHEREAS**, the objectives of the *Agreement* are to strengthen and enhance economic, trade and investment cooperation between the Parties; progressively liberalise and promote trade in goods and services as well as create a transparent, liberal and facilitative investment regime; explore new areas and develop appropriate measures for closer economic cooperation between the Parties; and facilitate effective economic integration of the newer ASEAN Member States and bridge the development gap among the Parties;

**WHEREAS**, the *Agreement* provides that the Parties shall negotiate the establishment of an ASEAN-India Regional Trade and Investment Area (RTIA);

**WHEREAS**, Article 16 of the *Agreement* provides that it shall enter into force on 1 July 2004. Where a Party is unable to complete its internal procedures for the entry into force of the *Agreement* by 1 July 2004, the rights and obligations of that Party under this *Agreement* shall commence on the date of the completion of such internal procedures.

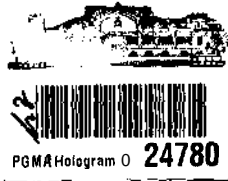
