NOW THEREFORE I, Somsavat LENGSAVAD, Deputy Prime Minister, Minster of Foreign Affairs declare that the Government of the Lao People's Democratic Republic, having considered the above mentioned Framework Agreement, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained.
